#### Please note:

a) Any federation wishing to submit an additional agenda item or a specific proposal for inclusion in the Agenda must do so in written form in English and/or French, along with the reasons for the proposal, to be received at FISA Headquarters in Lausanne no later than 09:00 hrs CET on 31 May 2009. - b) The Congress will attribute the 2013 World Rowing Championships, the 2013 World Rowing Junior Championships and the 2012 World Rowing Under 23 Championships. The deadline for the candidates competing for the honour and responsibility of hosting these championships to submit their final documents is 31 May 2009.
  - The Council will send an inspection team to each site during April and May 2009, and will meet with the representatives of all candidates on 21 June 2009. The Council's choices will be announced by the beginning of July to be presented for ratification by the Congress.
- c) The following positions on the Council are due for election at the Congress and nominations are called for those positions. Nominations for these positions must be made by the member federations of the persons nominated and must be received at FISA Headquarters no later than 09:00 hrs CET on 31 May 2009:
  - i) President
  - ii) Vice President
  - iii) Treasurer
- d) Federations are requested to advise FISA of the names of their delegates attending the Congress by using the "Congress Attendance Form" attached to this circular. Forms are to be received no later than 31 July 2009.

# 5. 2008 FISA Anti-Doping Survey

FISA's survey of all doping tests undertaken in rowing in 2008 is presented below. 50 National Federations responded to this year's survey and show a total of 4'156 tests made in the sport of rowing. Those Federations not responding to this survey may be subject to sanctions by the FISA Executive Committee.

Announcements of decisions on positive cases:

- 1. UKR Irina Iarosh tested positive in an out of competition anti-doping test carried out in Cairo, Egypt. The analysis of the sample showed the presence of oxandrolone and metabolites of nandrolone, both prohibited substances. The rower was banned from national and international competition for two years, until 17 January 2010.
- 2. SRB Goran Nedeljkovic tested positive for Amphetamines at the 2008 World University Rowing Championships in Belgrade, Serbia. The SRB M2- was disqualified and both gold medals were returned to FISU. The rower was banned from national and international competition for two years, until 18 November 2010.
- 3. GRE Ioannis Tsamis tested positive for Finasteride, a prohibited substance, in a national out of competition test on 22 April 2008. He received a six month ban until 21 October 2008.
- 4. NZL Dane Boswell tested positive for the substance Probenecide, a prohibited substance, in a national out of competition test on 17 November 2008. He received a two month ban.
- 5. IRL Finn Gebler tested positive for Tetrahydrocannabinal, a prohibited substance, in a national "in" competition test on 9 February 2008. The athlete was reprimanded and received a suspension for three weeks.

- 6. RUS Ekaterina Novikova tested positive for the prohibited substance Nandrolone in a national "in" competition test on 21 May 2008. She was disqualified and banned from competition for two years.
- 7. RUS Mikhail Burov tested positive for Furosemide, a prohibited substance, in a national "in" competition test conducted on 21 May 2008. He was banned from competition for two years.
- 8. RUS Maxim Liventsev tested positive for the nandrolone metabolite, norandrosterone, a prohibited substance, in a national "in" competition test on 12 October 2008. He received a two year ban.
- 9. RUS Petr Romanchenko tested positive for Carboxy THC, a prohibited substance, in a national "in" competition test on 12 October 2008. He received a six month ban from competition and from training within the structure of the national team.
- 10. RUS Dmitriy Sheredeka tested positive for Carboxy THC, a prohibited substance, in a national "in" competition test on 12 October 2008. He received a six month ban from competition and from training within the structure of the national team.
- 11. RUS Viktor Shakurov tested positive for Carboxy THC, a prohibited substance, in a national "in" competition test on 12 October 2008. He received a six month ban from competition and from training within the structure of the national team.
